


# MMCS TUITION COMPARED


\$ 14,956 Ave Tuition Private Schools in PA

# EXAMPLES

## HOW *does it* WORK?

\$ 16,287	Salary or Pass-through Income
\$ 500	PA Taxes Due (3.07%)
<b>\$ 500</b>	<b>Your Taxes Gifted to MMCS</b>
\$ -450	90% Tax Credit (at tax time)

\$ 50	10% Actual Taxes you will Pay
<b>\$ 550</b>	<b>Your Total Out-of-Pocket</b> <b>(\$500 goes to MMCS &amp; \$50 to PA Dept of Revenue at tax time)</b>

If you **donate as a business** you will be eligible to apply your tax credit in your quarterly filings to reduce the amount you owe until the tax credit is fully realized. You will be provided with a letter of proof. (CNI 7.99%)

If you **donate as an individual**, you can elect to receive your refund by check or direct deposit. (3.07%)

# BASICS of Educational Improvement Tax Credits

- 1** Minimum donation is \$500 and can be up to the full amount of PA State taxes owed
- 2** ONE page ONLINE FORM to COMPLETE (*takes less than 5 minutes*)
- 3** YOU submit your EITC donation to the MMCS partner Foundation
- 4** YOU receive a K-1 form following your donation
- 5** YOU then receive a tax credit for 90% of your donation at tax time
